*India's Strong Economy Continues to Lead Global Growth* is the headline on an August 2018 report from the International Monetary Fund. The report goes on: *India's economy is gaining momentum, thanks to the implementation of several recent noteworthy policies – such as the enactment of the long-awaited goods and services tax, and the country opening up more to foreign investors. Therefore, we expect economic growth to pick up to about 7.3 percent for fiscal year 2018/19 – meaning the year that runs from April of 2018 through March 2019 – from 6.7 percent in the year prior...*

Doing business in India offers immense business opportunities for U.S.-based companies. Over the past few years, the Indian government has liberalized the FDI norms, making India one of the most open economies in the world. The government has also implemented a number of measures to improve the ease of doing business in India by simplifying and digitizing the existing legal regimes.
